

INVESTMENT OBJECTIVE

The Fund will aim to deliver returns in excess of the benchmark over a long term time horizon.

INVESTMENT POLICY

The fund aims to achieve this by investing predominantly into global equities. This is performed through active and unconstrained management in both South African and foreign markets with a focus on equity opportunities within the offshore markets. The Fund will, apart from assets in liquid form, consist solely of participatory interest in Collective Investment Schemes which will invest in a diversified mix of assets, including but not limited to equities, property, preference shares, money market and fixed interest instruments. The underlying collective investment schemes are permitted to invest in listed and unlisted financial instruments in line with conditions as determined by legislation from time to time. The Fund will adhere to investment conditions determined by legislation from time to time.

HOW WE AIM TO MEET THE FUND'S OBJECTIVE

The management team track the asset allocation of reputable asset managers with large research capabilities. The research provides insight into where top professionals are allocating assets. FUND COMMENTARY

The fund has demonstrated a strong performance across various timeframes:

· Last Quarter Return: 5.38% • 6 Months Return: 6.96% • 1 Year Return: 14.07%

The Interactive Global Equity Prescient Fund of Funds delivered +5.38% for Q4 2024, bringing its annual return to a strong +17.16% in rand terms. Despite this, the fund underperformed the ASISA Global Equity General category average of +7.15% for the quarter.

Dividend-focused ETFs, such as the Schwab U.S. Dividend Equity ETF and Vanguard Dividend Appreciation ETF, faced headwinds due to weaker energy and financials sectors. In contrast, the iShares Core S&P 500 ETF, which gained +8.42%, was a key contributor, driven by robust performance in U.S. large-cap technology and consumer discretionary stocks.

The weakening rand amplified offshore returns, bolstering the fund's local currency performance despite muted dollar gains in emerging markets, particularly China.

GLOSSARY

Fund of Funds: A Fund of Funds is a portfolio that invests in portfolios of collective investment schemes, which levy their own charges, which could result in a higher fee structure for these portfolios

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

FUND SPECIFIC RISK

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.
