

INVESTMENT OBJECTIVE

The fund aims to create income and long term capital growth within the constraints governing retirement funds. The fund aims to outperform the market average of similar unit trusts without taking on more risk. The funds benchmark is the market-value weighted average returns of funds in the South African - Multi Asset - High Equity category.


INVESTMENT POLICY

The Fund invests in a mix of shares, bonds, property, commodities and cash. The Fund can invest a maximum of 30% offshore, with an additional 10% allowed for investments in Africa outside of South Africa. The maximum net equity exposure of the Fund is 75% and we may use exchange-traded derivative contracts on stock market indices to reduce net equity exposure from time to time. The Fund is managed to comply with the investment limits governing retirement funds. Returns are likely to be less volatile than those of an equity-only





FUND COMMENTARY

The fund delivered a strong 6.16% return for Q3 2025, outperforming the ASISA South African Multi-Asset High Equity benchmark at 5.37%. Gains were driven by broad equity strength both locally and offshore, supported by easing inflation, expectations of global rate cuts, and resilient corporate earnings.

Locally, resource (commodity) and high-dividend shares led the advance, with the Interactive SA Equity Prescient Fund (+8.56%) and Satrix Dividend Plus (+6.47%) delivering standout performance. Global exposure through the Interactive Global Equity FoF (+5.36%) and property holdings such as Harvard House BCI Property (+7.06%) also added value. The fund remains positioned with a measured equity bias, balancing local and global opportunities while maintaining diversification across income and property assets - well-placed to benefit from a broadening market recovery and easing monetary conditions.

GLOSSARY

Fund of Funds: A Fund of Funds is a portfolio that invests in portfolios of collective investment schemes, which levy their own charges, which could result in a higher fee structure for these portfolios.

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

INFORMATION & DISCLOSURES

The portfolio has adhered to its policy objective and there were no material changes in the composition of the portfolio during the guarter.

FUND SPECIFIC RISK
