

### **INVESTMENT OBJECTIVE**


The Fund will aim to deliver returns in excess of the benchmark over a long term time

#### **INVESTMENT POLICY**

The fund aims to achieve this by investing predominantly into global equities. This is performed through active and unconstrained management in both South African and foreign markets with a focus on equity opportunities within the offshore markets. The Fund will, apart from assets in liquid form, consist solely of participatory interest in Collective Investment Schemes which will invest in a diversified mix of assets, including but not limited to equities, property, preference shares, money market and fixed interest instruments. The underlying collective investment schemes are permitted to invest in listed and unlisted financial instruments in line with conditions as determined by legislation from time to time. The Fund will adhere to investment conditions determined by legislation from time to time.

The management team track the asset allocation of reputable asset managers with large research capabilities. The research provides insight into where top professionals are allocating assets. 

### **FUND COMMENTARY**

Netflix Inc

The Interactive Global Equity Prescient FoF C advanced 2.98% in Q3 2025, bringing its six-month return to 13.21% and one-year gain to 11.09%. Performance was supported by broad strength in developed-market equities, particularly in the United States, where expectations of rate cuts and resilient corporate earnings fuelled risk appetite.

Key contributors included the Invesco QQQ Trust (+8.94%), iShares Core S&P 500 ETF (+8.12%), and Vanguard FTSE All-World ex-US ETF (+6.93%), reflecting the rally in growth and innovation-led sectors. Quality-oriented exposures such as the iShares MSCI USA Quality Factor ETF (+6.63%) and VanEck Morningstar Wide Moat ETF (+5.65%) also added value. Dividend-focused holdings like the Vanguard Dividend Appreciation ETF (+5.88%) and Schwab US Dividend Equity ETF (+4.01%) lagged slightly as markets favoured capital growth over income strategies. The fund remains positioned toward high-quality global equities, balancing structural growth exposure with disciplined risk management.

# **GLOSSARY**

Fund of Funds: A Fund of Funds is a portfolio that invests in portfolios of collective investment schemes, which levy their own charges, which could result in a higher fee structure for these portfolios.

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

#### FUND SPECIFIC RISK
