The Fund will aim to deliver returns in excess of the benchmark over a long term time horizon.

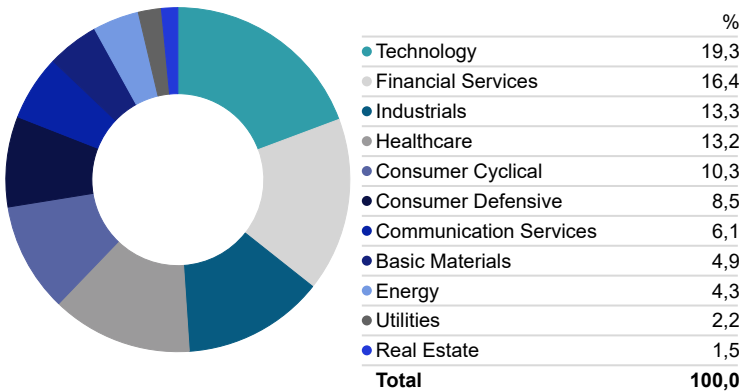
INVESTMENT POLICY

The fund aims to achieve this by investing predominantly into global equities. This is performed through active and unconstrained management in both South African and foreign markets with a focus on equity opportunities within the offshore markets. The Fund will, apart from assets in liquid form, consist solely of participatory interest in Collective Investment Schemes which will invest in a diversified mix of assets, including but not limited to equities, property, preference shares, money market and fixed interest instruments. The underlying collective investment schemes are permitted to invest in listed and unlisted financial instruments in line with conditions as determined by legislation from time to time. The Fund will adhere to investment conditions determined by legislation from time to time.

HOW WE AIM TO MEET THE FUND'S OBJECTIVE

The management team track the asset allocation of reputable asset managers with large research capabilities. The research provides insight into where top professionals are allocating assets. 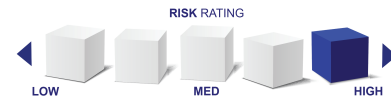

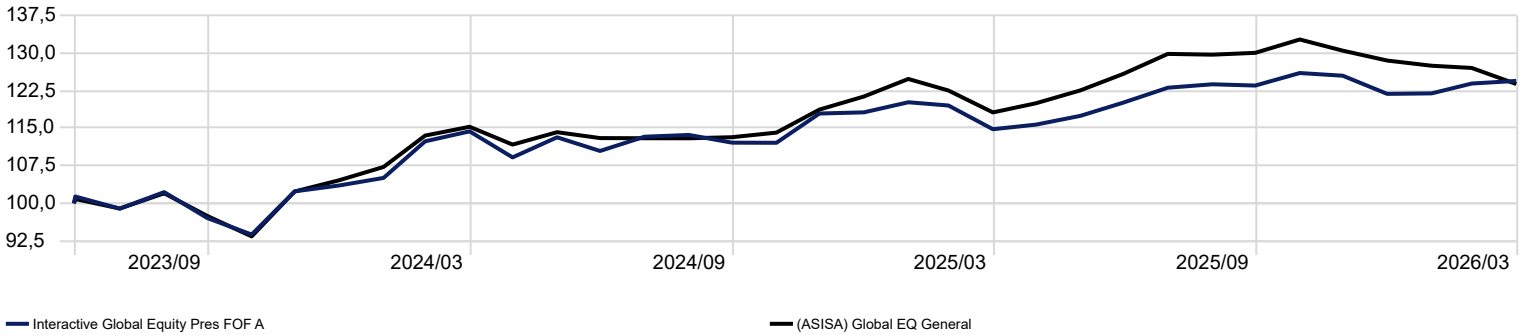

FUND COMMENTARY

The Interactive Global Equity Prescient Fund returned **2.42% over the past three months** and **1.34% over six months**, outperforming the ASISA Global Equity General benchmark, which returned **-3.64%** and **-4.78%**, respectively. Over one year, the fund delivered **9.67%**, ahead of the benchmark return of **4.79%**, reflecting strong relative performance across varying market conditions.

Performance over the period was shaped by **ongoing global market volatility, currency movements and dispersion across equity styles**, with the fund benefiting from its diversified and quality-focused positioning.

Positive contributions were supported by exposure to non-US and income-oriented strategies, with the Schwab US Dividend Equity ETF (+12.71%) a key contributor during the quarter. The Vanguard FTSE All-World ex-US ETF (+1.80%) also added value, benefiting from improving sentiment toward international equities.

Returns were partially offset by **weakness in US growth and quality segments**, with the Invesco QQQ Trust (-5.86%), VanEck Morningstar Wide Moat ETF (-6.59%) and iShares Core S&P 500 ETF (-4.34%) detracting amid pressure on large-cap US equities and technology-related exposures.

From a positioning perspective, the fund remains **well diversified across regions, styles and factors**, with a continued emphasis on **quality, income resilience and valuation support**. This balanced approach enables the fund to navigate changing market conditions while capturing long-term global equity growth opportunities.

GLOSSARY

Fund of Funds: A Fund of Funds is a portfolio that invests in portfolios of collective investment schemes, which levy their own charges, which could result in a higher fee structure for these portfolios.

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

INFORMATION & DISCLOSURES

FUND SPECIFIC RISK

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

Where a current yield has been included for Funds that derive its income primarily from interest bearing income, the yield is a weighted average yield of all underlying interest bearing instruments as at the last day of the month. This yield is subject to change as market rates and underlying investments change.
