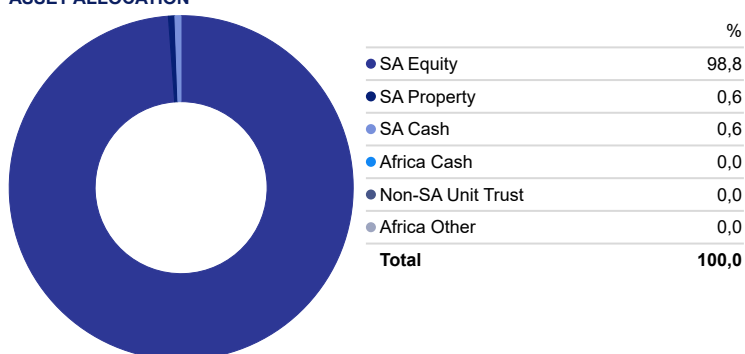
INVESTMENT OBJECTIVE

The fund is an actively managed South African general equity portfolio with a focus on maximizing total returns. The portfolio's objective is to offer medium to long-term capital growth. The portfolio will invest a minimum of 80% of its net asset value in South African equity securities, including listed shares on the Johannesburg Stock Exchange (JSE) and other approved South African exchanges. Up to 20% of the NAV may be allocated to money market instruments, cash, or other short-term investments during periods of elevated market volatility or when attractive investment opportunities are limited. The portfolio may invest across all sectors of the economy but will maintain diversification within sectors to mitigate concentration risk.

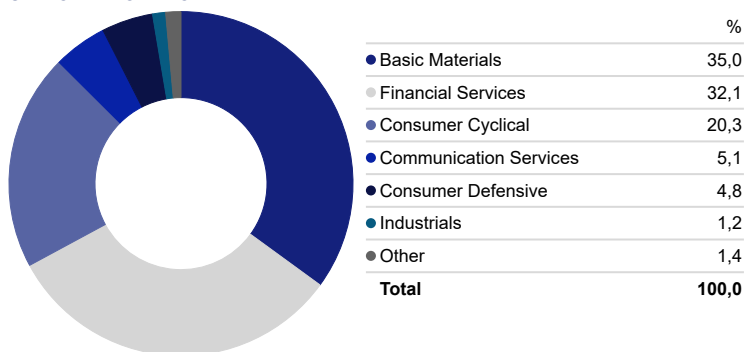
INVESTMENT POLICY

The portfolio has a long-term focus and invests in securities across all sectors of the JSE Securities Exchange which trade below their intrinsic value or have capital appreciation potential.

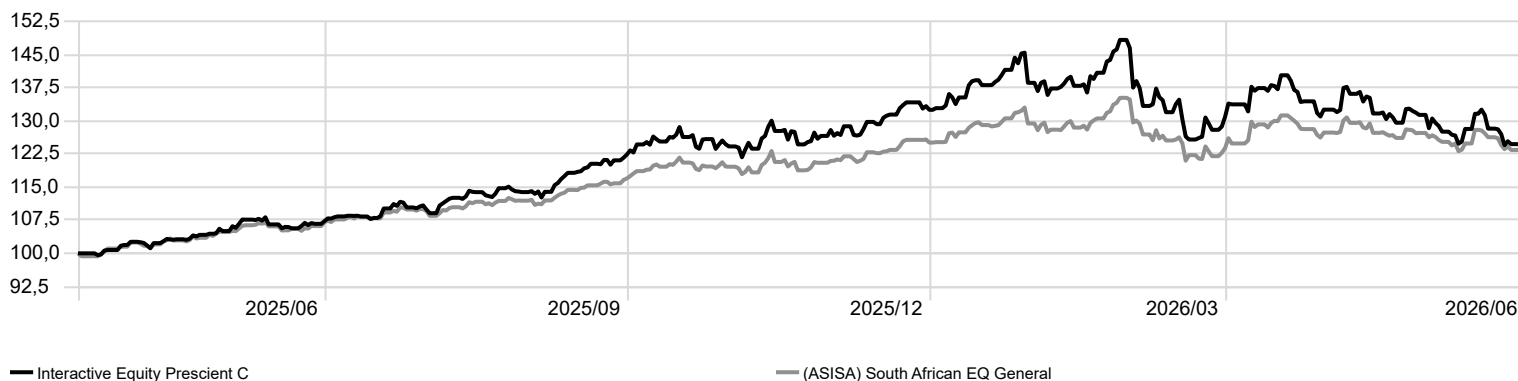

FUND COMMENTARY

The Interactive Equity Prescient Fund returned **-4.82%** over the past three months, compared with **-2.24%** for the ASISA South African Equity General category. Despite the challenging quarter, the fund has delivered **16.13%** over the past year, broadly in line with its benchmark, reflecting the strong performance generated over the previous twelve months.

The quarter was characterised by a sharp reversal in South African resource shares following exceptional gains earlier in the year. This rotation had a meaningful impact on performance given the portfolio's exposure to quality mining companies. Holdings such as **Gold Fields**, **AngloGold Ashanti**, **Impala Platinum**, **Northam Platinum** and **Valterra Platinum** experienced significant declines as gold and platinum prices corrected from elevated levels.

Despite this weakness, several domestic businesses delivered strong returns and partially offset the decline in mining shares. **FirstRand**, **Capitec Bank**, **MTN**, **Standard Bank**, **Anheuser-Busch InBev**, **Mr Price**, **Richemont** and **Anglo American** were among the leading contributors during the quarter, highlighting the strength of the portfolio's diversified exposure across financials, consumer businesses and industrial companies.

Although short-term performance was impacted by the rapid reversal in commodity markets, our long-term investment philosophy remains unchanged. The portfolio continues to focus on fundamentally strong businesses with attractive valuations, sustainable earnings and robust balance sheets. We remain constructive on South African equities, particularly given the attractive valuations available across many domestic sectors, while maintaining a diversified portfolio that reduces reliance on any single industry or commodity cycle.

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

FUND SPECIFIC RISK

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.
