INVESTMENT OBJECTIVE

The Fund aims to return CPI + 3% per annum through a full interest rate cycle while providing stability by aiming never to lose capital over any rolling 3 month period.

INVESTMENT POLICY

This Fund invests in local and offshore money market, bonds, property, preference shares, inflation-linked bonds and derivatives to meet the investment objectives. Fund performance can be generated from taking interest rate views or duration, yield enhancement via credit instruments, asset allocation between income producing asset classes, offshore exposure and also via the use of derivatives.

RISK PROFILE



WHO SHOULD INVEST

Investors seeking stable real returns and aiming to maximise income via exposure to primarily the South African Money and Bond markets. This Fund is suitable to investors with a short- to medium-term investment horizon and is Regulation 28 compliant.

RISK INDICATOR DEFINITION

These portfolios typically have no or low equity exposure, resulting in higher interest yields and stable capital values with the probability of capital losses over the shorter term (3 months) highly unlikely. These portfolios typically target returns in the region of 1% – 3% above inflation before tax over the long term.

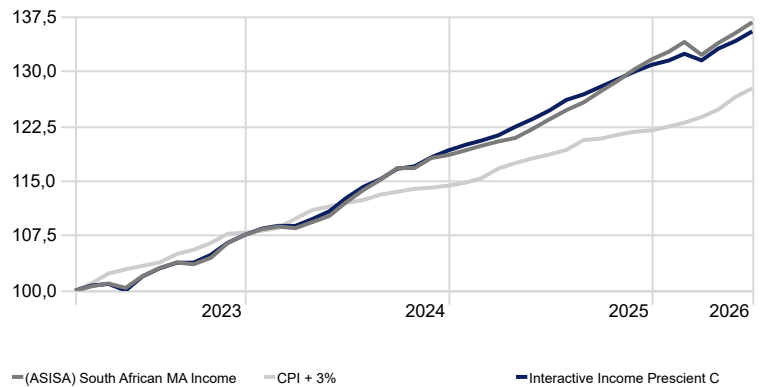

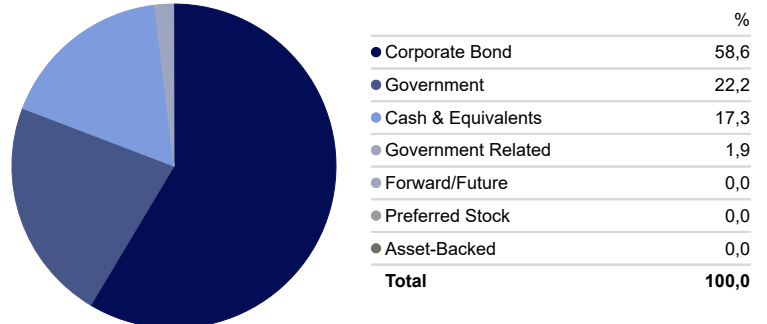

FUND COMMENTARY

South African fixed-income markets recovered strongly over the quarter, supported by easing geopolitical tensions, lower oil prices, renewed foreign investor demand and a firmer rand. Although inflation remained elevated and the South African Reserve Bank increased the repo rate by 25 basis points to 7.00%, markets viewed the move as reinforcing the SARB's commitment to price stability, supporting longer-dated bond yields. The quarter concluded on a constructive note following the ceasefire between the US and Iran, which saw Brent crude retreat sharply, improving the near-term inflation outlook and supporting a further rally in local bonds.

Against this backdrop, the Fund continued to focus on capital preservation, liquidity and high-quality income generation while benefiting from income and selective duration exposure as bond yields declined. Elevated carry from money market and floating-rate instruments provided a stable return foundation, while fixed-rate bond holdings contributed positively as yields moved lower. Positioning remains balanced: although lower oil prices have improved the near-term inflation outlook, the SARB's hawkish stance, July administered price increases and ongoing geopolitical uncertainty support maintaining a prudent risk profile.

The Fund delivered positive performance over the quarter, outperforming its benchmark. Duration assets added at the end of March contributed positively during April, while fixed-rate bond holdings were the standout contributor during May as bond markets rallied.

The Fund's forward yield remains attractive at 8.67%, with a total duration of 1.54 years. The current risk profile remains aligned with the Fund's objective of delivering consistent income while preserving capital, and we believe the portfolio is well positioned to continue achieving its long-term return objectives.

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

FUND SPECIFIC RISK

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.
